Dear Vendor,

We would like to welcome you to the 39th Annual Popcorn Festival as a participating vendor. Please take a moment to review the following reminders:

- ✚ **For vendors requiring 110V electricity:**
 - It is the responsibility of the vendor to provide the electrical cord from the vendor's space to the electrical outlets set out by the Popcorn Festival electrician
- ✚ **For vendors requiring 220V electricity:**
 - It is the responsibility of the vendor to provide the electrical cord from the vendor's space to the electrical box for the Popcorn Festival designated electrician to connect
- ✚ **For vendors requiring water service:**
 - It is the responsibility of the vendor to provide the hose from the vendor's space to the water faucets provided by the Popcorn Festival
 - It is the responsibility of the vendor to provide a water backflow valve as required by the Grant County Health Department
- ✚ **For vendors serving food:**
 - Continuing in 2011, all food vendors must obtain the appropriate Food Service License (for profit) or Permit (not for profit) from the Grant County Health Department within 10 days of the beginning of the Popcorn Festival
 - Failure to do so will result in a late fee of \$50.00 being assessed by the Grant County Health Department
 - The Application for the Food Service License or Permit can be found at www.popcornfestival.org or by contacting the Grant County Health Department
 - Click on "Registration"
 - Click on "Merchandise or Food Vendor Registration"
 - Click on "Health Forms"
- ✚ **For vendors requiring lodging or camper service:**
 - The Popcorn Festival does not provide overnight accommodations by way of motel/hotel or camper service to any vendor
 - The nearest accommodations include Marion (I-69 Exit 64), Gas City (I-69 Exit 59), and Warren (I-69 exit 78)
